#### HISTORY OF THE TRUST

The NZART Radioscience Trust was established by NZART (Inc.) in January 1998 to encourage interest in radioscience.

# **OBJECTS OF THE TRUST**

To promote and encourage education in radioscience, whether by the payment of course fees for worthy candidates, the provision of prizes on a competitive basis for excellence in education activities, or otherwise as the trustees think fit.

# **CHARITABLE REGISTRATION**

The Trust is registered by the New Zealand Charities Commission under the Charities Act 2005.

# **ELIGIBILITY FOR GRANTS**

The criteria for eligibility of applications for projects include the following:

- Schools, Institutions, and individuals resident within the 16 Regions of New Zealand and including the Chatham Islands.
- Clubs, organisations, societies, foundations and other recognised educational groups operating in New Zealand.
- Clubs and amateur radio groups who seek partnerships or support for open educational projects.
- The Trust does not grant funds to NZART, NZART Branches or affiliates for member only activities or member benefits.
- The Trust does not grant funding for group or individual activities outside New Zealand.
- The Trust does not grant funding to cover wages or administrative costs, building alterations or the cost of consumables such as power and telephone etc.

#### **CONDITIONS OF ANY GRANT**

Any grant awarded by the Trust is subject to any conditions the Trust Board may consider necessary including:

- Funds must be applied solely to the project approved by this application, and any unused portion shall be returned to the Trust on request.
- Projects must be completed within 12 months of the grant being approved by the Trust Board.
- The recipient shall acknowledge the NZART Radioscience Educational Trust within the project and in any subsequent media coverage or promotions within the community.
- The recipient shall provide a summary report at the completion of the project.
- Applications shall be accompanied by a quotation(s) covering the full value of the grant. Grants made by the Trust do not incur GST. Any grants received from the Trust, by any individual or any organisation that is GST Registered with the Inland Revenue Department, are exclusive of Goods and Services Tax (GST).
- The Trust reserves the right to publish full details of the grant in the NZART publication Break In.
- The decisions of the Trust Board are final.

#### **AUTHORISATION AND OWNERSHIP**

For schools, educational institutes etc. the application must be signed by the HoD Science or Principal. At the conclusion of the project materials and/or equipment purchased with his grant shall remain the property of the school or institution.
