# From NZART Conference 2001 – Remit Results:

#### Remit 1

That the NZART constitution be amended to eliminate Electoral districts. After discussion, was put and lost.

## Remit 2

Requests Council to change rule 4, Membership and rule 7 Subscription, to provide membership by affiliation in the same manner as sporting organisations. **This remit was the subject of much discussion, was put and lost.** 

## Remit 3

This remit charges Council to investigate the possibility of benefits in revising the method of collection of Branch and Association dues, and report back its findings to Conference in 2002.

# This was also the subject of a long period of discussion, but when put, was declared lost on voices.

## Remit 4

That NZART council investigate options for combining Branch subs and NZART subs in one transaction.

This remit was put and lost on voices

## Remit 5

This Conference urges Council to Publish Break-In 11 times a year Publish the Callbook Bi-annually, for sale to all radio amateurs. **This remit was lost on voices.** 

## Remit 6

That NZART request the MED to allow operators holding novice licences, to operate on the 70cm band.

This remit was carried on a vote count.

## Remit 7

That NZART consider removing the need to claim poverty for a reduced subscription, and instead, rely upon proof of being the holder of a community service card. **This remit was lost on voices.** 

#### Remit 8

That NZART policy be amended to support the removal of Morse code as an IARU requirement for an amateur licence to operate on a frequency below 30MHz. And that NZART continue to encourage and protect the use of Morse code recognising its value as an effective and efficient mode of Communications. Terry Carrell ZL3QL explained the fine points of this remit.

# The Ministry and Licences – An update from Administration Liaison Officer Fred Johnson ZL2AMJ:

You will recall that our administration, the Ministry of Economic Development, Radio Spectrum Management Group, called for submissions earlier this year about a proposal in a document DP15: "Formulaic Approach to Licences". The "Headquarters Info-Line", Issue #5 of 18 March 2001, advised that "no change" was proposed to the amateur radio licensing method or procedures so the matter could be safely ignored by amateur radio licensees.

The Ministry has responded with a new document, DP15A. This can be found with the original document at: <u>http://www.med.govt.nz/rsm/publications/dps.html</u> The DP15A document itself is at: <u>http://www.med.govt.nz/rsm/publications/dps/dp15a.pdf</u>

The essence of the response for radio amateurs is: "4.2.2.1 The sixteen submissions from amateur operators almost all made the singular assumption that the outcome of DP15 would be an increase in amateur licence fees. It was clearly stated in the discussion paper that amateurs would continue to be licensed as a "station-based" service, and it is believed that the paper was clear in this regard. Applying the formula approach to station-based licences, including amateurs, would be unlikely to change

the existing fees unless the level of costs applicable to that particular category has been largely understated by the current fee level. In the case of the amateur service, this is most unlikely."

## **New Radio Regulations:**

The latest words from the MED about the new Radio Regulations: "now hoping for bringing into force by Order in Council on 1 September 2001".

## Progress Report Amateur Radio Examinations 2001

The examinations under the new system got off to a slow start but are now slowly building up in frequency. There have been 50 candidates, 7 females and 43 males during this past year. The average pass mark for the exam was 45 questions correct out of 60. The highest pass mark was 60 and the lowest mark attained was 24, that being the one and only failure,

It is interesting to note that only 7 of these people was under the age of 20 and 3 persons were over the age of 70 years. The average age is 43 years and the youngest candidate was 13.

We need to thank the many new examiners who came forward to help run the new system. We have 43 Branches and exams have taken place in 16 examination centres. Gisborne, Hutt Valley, Palmerston North and Whangarei have had the most candidates.

I still make up all of the stationary used in this exam system so as to keep costs down. Branches are allowed to deduct \$5 per candidate out of the \$25 fee, but this is rarely done except by Auckland Clubs.

I hope that Council and members feel that I have served you well.

# **Report on NZART Morse Testing April 2000 – March 2001**

This was a moderately busy year, with 29 candidates tested by 11 branches. Testing was also carried out by ZL1AN.

It is quite apparent that the Branches are thoroughly preparing candidates as evidenced by the failure of only one candidate! A pass rate of about 97%.

Almost all testing is now done by the computer testing system devised by Gary Bold ZL1AN (aka The Morseman). The materials for the cassette testing are still available to meet the occasional request from Branch testers.
