NZART Council approved publication of the following Recommendations at its August meeting.

INTERIM RECOMMENDATIONS TO COUNCIL

Branch 30 Otago has applied to increase the transmitter power of 690 Mount Cargill (repeater transmit frequency 146.900 MHz, repeater receive frequency 146.300 MHz). An engineering evaluation confirms that the repeater can continue operating on the existing frequencies, at the increased power.

Branch 30 Otago has applied to increase the transmitter power of the 465 Highcliff Digi (transmit and receive frequency 144.650 MHz). An engineering evaluation confirms that the repeater can continue operating on the existing frequency, at the increased power.

Branch 30 Otago has applied to increase the transmitter power of 665 Highcliff (repeater transmit frequency 146.650 MHz, repeater receive frequency 146.050 MHz). An engineering evaluation confirms that the repeater can continue operating on the existing frequencies, at the increased power.

Branch 35 Balclutha has applied to increase the transmitter power of 675 Kuriwao (repeater transmit frequency 146.750 MHz, repeater receive frequency 146.150 MHz). An engineering evaluation confirms that the repeater can continue operating on the existing frequencies, at the increased power.

Branch 74 Wellington VHF Group has applied to increase the transmitter power of 710 Belmont (repeater transmit frequency 147.100 MHz, repeater receive frequency 147.700 MHz). An engineering evaluation confirms that the repeater can continue operating on the existing frequencies, at the increased power.

Branch 78 Far North has applied to re-locate 6775 Paikauri to Akatere (repeater transmit frequency 146.775 MHz, repeater receive frequency 146.175 MHz). An engineering evaluation confirms that the repeater can continue operating on the existing frequencies, at the new location.
