The reasons for my support are:

Amateur Radio (commonly known as "Ham Radio") is a recreational and self-training activity and a communication service that is established and governed by international statute. It fosters cutting-edge experimentation in radio-technology and related topics, and provides a pool of scientific research worldwide. As a result of this widespread radio expertise, Amateur Radio is in the forefront of emergency communications facilities, both internationally and locally. Amateur Radio requires appropriate antennas: it can only function satisfactorily with antennas of appropriate sizes and heights. Amateur Radio operators, by regulatory definition are without pecuniary interest, so have limited resources to meet unduly restrictive requirements for planning purposes

Amateur Radio operation is mainly carried from an operator's residence. The Council should ensure that reasonable accomodation is made within the District Plan, without undue restriction, for the necessary antennas to be erected, especially those installed incidental to the occupation of a dwelling, so providing for the full and unimpeded continuance and growth of the amateur service and the social and educational opportunities it provides.

I/we oppose the proposed plan since it fails to accommodate as permitted uses the reasonable requirements of amateur radio operators and the amateur radio service, through excessive limitations on the height, location and numbers of radio antennas (aerials) and their supporting structures.

I wish to have the plan amended to remove the unduly severe restrictions of the proposed plan on the amateur service, so as to allow as permitted uses antennas erected at proper height and dimensions and in sufficient number for communications effectiveness and experimentation and otherwise to reasonably accommodate amateur radio service communications.

I/we seek the following decision from the Waikato District Council (give precise details):

In all zones except the pa and recreation zones, and in particular in the living zone, rural zone and the country living zone for/as permitted uses;

Increase the height limits for amateur antenna supporting structures to 15 metres,

Reduce the setbacks of simple pole structures to 0.5 metres on all boundaries, and for tower/mast structures to 1.5 metres,

Remove the application of height control planes to amateur antennas and their supporting structures,

Provide differentiation between antennas and their supporting structures,

Allow amateur communication satellite dishes up to 4 metres diameter,

No limitation on numbers of amateur antennas and on their supporting structures,

Allow simple pole structures closer to mean high water springs, lakes and rivers and in flood control areas **Add** to Appendix P Term P10 Meaning, d) amateur radio antennas and their supporting structures other than a building.

Delete from Appendix P Term P7, the words "... It includes any suppoort structure and guy wires. An aerial may include a single mast or pole supporting several antennas. Where a wire or other antenna is supported between 2 or more poles, each pole is considered to be an aerial. ..."
