NZART Council approved publication of the following FMTAG Notes, at its December meeting, for the information of, and seeking comments from, NZART members.

INTERIM RECOMMENDATION

Branch 12 Hamilton has applied to change the operating frequencies of its BBS National System access station, located at Seddon Road, map reference NZ260 S14 102773. The transmit frequency will change to 434.975 MHz and the receive frequency will change to 439.975 MHz. An engineering evaluation confirms that there will be no interference to other stations.

Being a Councilor of the NZART

You will all be aware that nominations are being called for the position of NZART President and Council representing the Northern, Central, Midlands and Southern districts.

This article is edited from a document written by Michael Owen VK3KI entitled Being a director of the NZART" I have taken Michaels' excellent words and given it an NZART and ZL slant.

In VK, the WIA directors have given some thought and discussion as to what qualities are required in an individual who puts his or her name forward. I have tried, in editing this to give the ZL perspective, and as such this also represents some of my personal views.

I think it is worth raising the whole question because I am sure that anyone considering nominating will think about what he or she can contribute to the NZART and then, when members are asked to vote, they will consider what each candidate can contribute, and hopefully look to a Council with synergistic skills and experience.

The NZART Council does not meet personally very often, usually only two times a year. The monthly Council net on 80m has its limitations, some subject matter is confidential and can't be openly discussed, and at other times the propagation conditions on 80m prevent good and full discussion from taking place. Accordingly, Councilors communicate sometimes by phone and mainly by email, more or less on a daily basis. That means that you do have to be able to express yourself adequately in writing. The monosyllabic response does not contribute much, and the point of exchanging views is to try and ensure that all points are properly considered.

You also have to read a lot. Much of what has to be read is dry, regulatory stuff. Certainly not scintillating! That is because Councilors are asked to provide input on many policy issues, whether it is a draft paper, responding to a discussion paper on issues that may have an impact on the Amateur Service, or just a report on an area where the NZART is represented. Much of the important work of Council is involved in things that are not the fun of amateur radio, rather what many find much less interesting.

In addition, while each Councilor may take a special responsibility for particular matters, such as liaison with our valued officers or membership, NZART Council relies on people who are appointed as coordinators or officers to look after aspects such as the QSL Bureau, FMTAG, and many others.

On the other hand, a Councilor who takes responsibility for a matter has to ensure that the matter is brought to finality. You not only need the time to deal with the daily emails, but also to complete particular tasks you undertake.

Does that help identify the skills and experience that the Association needs on its Executive Council?

Actually, what Council needs is a mixture of skills. In my view, underlying Council's approach to virtually every question, the economics of publishing a book or magazine, the management of the amateur qualification examination system, taking responsibility for the financial outcomes of the Association, the subscriptions we charge, the insurances we seek, all involve a mixture of managerial, accounting, financial, commercial and other skills. NZART would not be served by a Council made up solely of accountants any more than it would by a Council of only communication engineers.

Yes, of course we want true amateurs. But a mix of technical, managerial, commercial and professional experience and skills at Council level means that the NZART is better equipped to meet the challenges of the next period.

Does it matter from where people come?

Although Councilors are elected from each call district, no one elected to Council should expect to exclusively represent a particular group or area. Each Councilor must act in the best interests of all members of the Association. So, in that sense, it just does not matter from where a Councilor comes.

But it is obviously important that Council has a mix of people from different areas. I am sure that if all Councilors came from Auckland or Wellington, they would have little understanding of the perceptions and needs of amateurs in other areas. Thus Council benefits from a mix.

It has been suggested that a thick skin is also needed. Unfortunately, there is some truth in that. Council cannot act to please all members at all times. For example if 80% of amateurs supported an entry level licence during the consultation process, then 20% were opposed. Some of those who disagreed with the introduction of an entry level licence would continue to disagree with NZART working to make it work successfully, sometimes in an antagonistic way.

Some would like NZART to be some sort of Spectrum Police. NZART cannot take that role, it is clearly a function of central government through the Radio Spectrum Management branch of the Ministry of Economic Development. Those who do not accept that position can also be antagonistic.

Above all else, NZART must continue to attract new members. A Councilor must be prepared to go to meetings and events where NZART can be promoted.

Being a Councilor of NZART is nothing like being a member of a tennis club committee, where there is a monthly meeting and all correspondence is read out, every payment is discussed, and every issue like whether the club can afford better biscuits is discussed.

Being a NZART Councilor means a lot of time, a lot of effort, a lot of reading and a lot of writing. You may also find that you have to meet some travel and other incidental costs, not all of which can be claimed back from the Association.

But, as NZART faces new and real challenges, if you have the skills and experience and the time and the interest, then it can be totally satisfying, because you are working to secure the future of amateur radio.

A Lookup System For SMART

On the home page (http://www.nzart.org.nz/nzart/) you will find in the right hand column a form where you can enter a callsign. Once a callsign is entered and the "submit" bar clicked, the form will go and get the callsign information from the MED SMART database.

This service is given to the NZART Web by Andrew ZL3AME.

The lookup service is done by the form, held on the NZART home page, requesting data from a Python script program running on Andrew's web server. Next the Python script looks for the data from the MED SMART database, formats it, and shows it in a page on Andrew's web server.

Andrew points out that the query may be slow, (my testing doesn't show this in any way EDITOR) and that its continued operation is not guaranteed. Also that NZART or Andrew does not take any responsibility for it or the consequences of using it.

- 1. Nominations **must** reach the Returning Officer by **31 December 2008.** The Returning Officer has no discretion to receive late nominations even if postmarked prior to that date. **Facsimile nominations cannot be accepted.**
- 2. Allow ample time for transit by post. Holiday mail is often delayed.
- 3. **Nominees** may submit biographical details and photo to the Returning Officer at the address overleaf by **10 January 2009**, for probable inclusion in the January/February 2009 issue of Break In. Endorse the envelope "**BIOGRAPHY**". The Returning Officer, (who has the authority to edit details submitted), suggests a limit of 200 words.
- 4. No nomination should be presumed to be in order until acknowledged in writing usually within seven working days.
- 5. Ensure that addresses are shown above for acknowledgements as often in the heat of the moment, this detail is overlooked.
