Electronic copy of call book a request received by ZL1PSH

- Once up and running, can include a member log in
- Back issues of Break-In/Call Book will then be available for members only
- Electronic copy will be watermarked and sent out after members receive hard copy.

Council considering producing electronic copy of call book only once the above (membership database) is available. Costs will be reduced (no printing or postage).

Digital version of Break-In doesn't necessarily reduce costs, some will still want hard copy and producing less will cost more to print.

ZL1PSH queried the 'Fighting fund of \$400k', how does NZART run at a deficit. Reason to build up – run for 12 – 24 months without additional income, after that the Association will close.

The reserves are mainly built up to cover the above scenario, however money can be used to fight the loss of spectrum or assist in legal fees for the rights of amateurs on a local government issue.

Quotes for colour – if can be included in current costs then go ahead. Budget figures discussed but not increased.

03/18 ELG Officer – ZL2ASF

ZL2UFI hasn't received much from ELG – ZL2ASF advised objections in the past not valid.

- ELG emails not received by RSM, set up a gMail account?
- 60 m Richard/Stuart were to negotiate with RSM re power? Nothing appears to have been done. ZL2TW confirmed that it is to be included in the GURL next year. EIRP suggested 15 watts and could be increased.
- 21 23KHz becoming available, need to talk to 60 m people, ZL3AB/ZL3PAH
- Realme log in required to RRF
- 2 m/70 cm band plan appears to be coming along well

Appears to be an overlap between IARU, ALO's & ELG – do they need to communicate more?

Repeater licensing monies to be better documented. Suggest Steve copy Debby on all license requests and can confirm payment is received.

03/19 ALO Officer - ZL2TW

ZL2TW officially resigned from position of ALO. Feels he has dropped the ball on the Standards meetings. Too busy at work as a doctor – all completely understand. Richard will continue in the role at this stage but is due back in NZ in a couple of weeks. 5 MHz international allocation.

Waiting to hear about 3.4/3.41 Gig or 10MHz – G band submission.

Tenure with Chorus okay now, but don't want a formal agreement. Happy to carry on negotiations with Chorus. Has suggested any trustees on Chorus sites, may want to locate elsewhere.

03/20 AREC CEO - ZL2TYR

Govt funding

- Xero financials running well
- Membership systems in Friendly manager, approx. 200 have completed registration.
- Marketing & branding, recruitment info available within induction packs.
- Website in production, finalising content, more up market.
- SharePoint/Teams 365 rolled out for all users.
- Training courses being developed. Bracken integrates with membership sets competency levels
- Project Manager overseas but will start on Tranche 2 IT projects
- Budgets commence at least 18 months ahead of time
- Nineteen business cases developed for future funding. Reviews ongoing to requirements for our future needs. As yet no additional questions been asked by government.
- Biggest issue, branches cannot grow members. GL sits in branch who is a volunteer, looking at including in funding to pay these people.
- Include CPI adjustment didn't approve originally
- More paid staff required, hoping to find .75 marketing person, plus four full time regional managers with vehicles and four more group leaders.
- This will help grow branch membership and AREC
- Full time national support Coordinator this will add to national team. This all equates to \$3.8m over two years
- All additional payroll will require assistance to pay these people. Could set up their own payroll and not place additional time on NZART.

ZL2UFI – we would like to bankroll off marketing with AREC.

Huge amount of jealousy regarding money being spent by AREC. More communications required to be transparent about this and why it is being spent.
